RE: Agreement of Cooperation between Vanguard Africa and Akere Muna

Vanguard Africa is honored to support Mr. Akere Muna and his efforts to potentially seek the presidency of Cameroon and to assist in boosting his profile, as well as expanding his professional network and media contacts in Washington, DC ahead of the upcoming election.

This Memorandum of Understanding (MoU) is to confirm that Mr. Muna, and his campaign associates, have agreed to work with Vanguard Africa as its primary agent to provide support during the period of August 5-10, 2017. During this time, Mr. Muna will be in Washington, DC for several days of high-level consultative meetings, including with the Vanguard Africa team.

During the time period of August 5-10, Vanguard Africa agrees to:

- 1) Undertake sole responsibility for organizing and facilitating meetings with officials at the U.S. State Department and U.S. Congress, key NGO leaders, and influential media contacts in Washington, DC.
- 2) Plan and participate in a consultation meeting with Vanguard Africa staff -- that will include our key board members -- in order to take stock of the week's meetings, as well as discuss campaign priorities, overall strategy and rollout in the context of the upcoming presidential election in Cameroon.
- 3) Before your arrival, Vanguard Africa will circulate a meeting agenda and will take comprehensive notes during each meeting in Washington, DC. We also agree to identify key meeting takeaways and circulate proposed next steps at the conclusion of your trip.

In order to legally undertake these tasks, Vanguard Africa must register with the U.S. Department of Justice and the Foreign Agents Registration Act (FARA), and pay the related fees. To cover the costs associated with the filings, legal proceedings and related work associated with our partnership during this period, Vanguard Africa will require an overall and upfront payment of **\$15,000 USD.**



Complete Agreement


This Agreement is the complete agreement of the parties and supersedes any previous agreements, whether written or oral, between the parties. No agreement or understanding, oral or written, in any way modifies the terms and conditions set forth herein, unless noted as an addendum to this contract, dated after this contract, and signed by the President of Vanguard Africa.

Since we will be acting at your direction, you agree to indemnify and hold Vanguard Africa and our agents harmless with respect to any claims or actions for discovery. You also agree to indemnify and hold us and our agents harmless with respect to any claims or actions for libel, slander, defamation, copyright infringement, idea misappropriation or invasion of rights of privacy arising out of our consultation and/or any materials or information supplied by you where we have acted in good faith and in accordance with your instructions; it being understood and agreed that this indemnity shall not extend to any claims or actions for libel, slander, defamation, copyright infringement, idea misappropriation or invasion of rights of privacy where we have acted contrary to your instructions or otherwise have acted with gross negligence.


Any action or break of this Agreement, for enforcement of this Agreement, or for any cause of action purported to arise out of this Agreement can be commenced in the American Arbitration Association (AAA) in the District of Columbia. Each party agrees that the District of Columbia is the proper forum for the commencement of any legal action by any party to the Agreement.

Dedicated work on this project will immediately begin upon receipt of signature and the predetermined fees into our bank account. We look forward to a potentially long and productive relationship with your campaign and we are eager to begin working on your behalf.
